-Always looking for ways to improve participation at qualifiers. Some suggested lowering entry fees, motion was made but was not accepted, fees will stay the same at this time.

-A question was asked from a club in a situation where they have 18 members as to how many can be sent to NSF, 6 member club sends 1 pro 1 co, 20 member club sends 2 pro 2 co, etc. We have had clubs split in past to send more if they don't meet numbers criteria, however remember that means there will need to be separate reps to attend meetings, separate youth/conservation projects and a pro and co must fish 1 qualifier as well.

-Mr. Bass has had poor participation the last few years, talked about changing format, etc. -Motion made to keep Mr. Bass as is for 2020, motion accepted.

-Elections for president: Chad Kline nominated and acceted, will be official at Convention but will work with Becky on any outstanding issues. Elections for Conservation Director, Nathan Greawin nominated and accepted, he will continue his position. Vice president/tournament director, no nominations at reps meeting, please talk to club members and get any nominations to Becky by November 1<sup>st</sup>. If we don't have a tournament director, we don't have any one to run qualifers!!!

-For 2020. TBF will give \$10.00 to each State Federation for each NEW member over what they had the previous year. Dues still remain the same though.

-Tournament Committee met October 3. Lakes have been selected for qualifiers for 2020 and 2021, with NSF being hosted by our state in 2021. These are pending permit approval.
