**Rules:** Interpretation of these rules shall be left exclusively to the Tournament Director.

**Sportsmanship:** Competitors are expected to follow high standards of sportsmanship, safety, and conservation. Any infraction of these fundamental principles may be deemed cause for disqualification. No alcoholic beverages, stimulants, or depressants will be allowed during the tournament.

**Boating Conduct:** Safe boating conduct must be practiced by all tournament competitors. Each competitor is required to wear a properly fastened Coast Guard approved chest type life preserver at all times when the combustion engine is running. Failing to adhere to this rule will result in immediate disqualification.

**Boat & Motor:** All boats used must be at least 14 feet in length. All boats used in competition, regardless of size, must be equipped with a working lanyard type kill switch. This ignition kill device must be attached to the driver's body any time the combustion engine is operating. Each boat must be equipped with a properly aerated live-well capable of sufficiently maintaining a 6 fish limit of bass.

**Fishing Methods:** Only artificial lures may be used, no "live bait" or "prepared bait" will be permitted, with the exception of pork strips, rinds, etc.

**Tournament Waters:** Lake Monona, Lake Waubesa, Upper Mud Lake, and the Yahara River up to the 12/18 bridge. The Yahara River is off limits starting at the first bridge upstream from Lake Monona and downstream starting at Babcock Lock as well as between Lake Monona and the 12/18 bridge.

**Fishing Areas:** Competitors are not allowed to fish within 50 feet of another competitor's boat that is already anchored. Both competitors must remain in the boat at all times during tournament hours except in the case of an emergency. Competitors may not leave the boat to land fish.

**Scoring:** Standings and final winners will be determined by the total weight of each teams catch. The limit will be 6 fish consisting of any combination of largemouth and/or smallmouth bass. Bass must be a minimum of 14" in length- any bass presented for weigh-in that do not meet the minimum 14" threshold will result in disqualification. Any bass that appear to be altered in any way shall be weighed at the discretion of the tournament director. Any dead bass weighed in shall be assessed a 4 ounce penalty per fish. This penalty will also be applied to fish weighed for the big bass pot.

**Tie-breakers:** Big bass breaks total weight tie and total weight breaks big bass tie.

**Late Penalty:** Late=Disqualification.
