The tournament payout for the Angler of the year is being increased for the 2024 season. Based on the point standings after the three qualifying tournaments, the payouts will be:

Boater: 1<sup>st</sup> Place \$5,000, 2<sup>nd</sup> Place \$800 & 3<sup>rd</sup> Place\$400 Co-angler: 1<sup>st</sup> Place \$2,500, 2<sup>nd</sup> Place \$400 & 3<sup>rd</sup> Place \$200

## **New Business:**

Starting this year Boaters and Co-Anglers can sign up on the Entry Forms as either linked or individually. In the event that more boaters are signed up than co-anglers an observer will be assigned. In the event that we have more Co-anglers than boaters a waiting list will be developed and the assignment of Co-anglers will be developed based on the earliest entry forms first.

The deadline for entry will be Friday the week prior to the tournament, based on post mark date.

Starting in 2025 we are planning to establish Qualifier dates in the months of May, June and July. We will be working to establish traditional weekend dates during the same time periods each year. The open tournament will move to October.

Membership dues determine the number of available discounts from our sponsors. It is based on the paid memberships as of January 31<sup>st</sup>. Paid memberships are due by December 31<sup>st</sup> each year with a deadline of January 15<sup>th</sup>. Memberships paid after these dates effect the total number of available discounts from our sponsors.
